



## Bio Security

- 1) I have health-checked the birds before leaving my premises.
- 2) None of the birds have been mixed with other birds that have travelled from another gathering in the last seven days. (If birds return to your holding they must be kept isolated and health monitored for one week following this sale).
- 3) All cages, crates, baskets, receptacles and other containers must be clean of birds droppings or other materials of bird origin before leaving their premises. The Auctioneers will refuse entry of any birds travelling in containers which do not meet the above requirements.
- 4) I will properly cleanse and disinfect all cages, crates, baskets, receptacles or other containers that I have brought to the gathering before leaving the premises.
- 5) I will permit the birds to be inspected before being taken to the selling pens and I will accept the Auctioneers and/or their staff decision without objection if entry is refused.
- 6) I understand and agree to the Licensee notifying the APHA of any poultry that fail the inspection or show any signs suggestive of Avian notifiable disease. Such birds will be kept isolated from other birds until examined via a veterinary inspector and written authority from APHA permitting them to leave the gathering has been obtained. I will reimburse the auctioneers for all reasonable costs involved in this matter.
- 7) No person will be allowed into the gathering showing signs of being visibly contaminated with faecal matter, feathers or other material of bird origin.
- 8) That to the best of my knowledge that the birds have not been in contact with any notifiable Avian disease agent and do not show any signs of infection.
- 9) I declare that all the poultry, captive birds or pigeons being sold at this sale have not been, or travelled outside the UK; and have not been in contact with birds with any signs, or have shown any signs of Newcastle Disease in the last 21 days.
- 10) I agree that I have read and will comply with the Bio-security information provided and that to the best of my knowledge my birds (detailed overleaf) have not been in contact with any notifiable Avian Disease Agents and do not show any signs of infection; and the birds have not originated from premises that are under restrictions related to confirmation of a notifiable avian disease, including from any temporary disease controlled zone or prevention zone imposed by the Secretary of State under article 6 of SI 2006/2702 (The Avian Influenza England Order).
