## Declaration

### 1.0 General

- a. All stock are moved in accordance with the relevant general licence and/or with a pre-movement licence if required.
- b. All stock should have officially approved ear tags.
- c. All stock come from premises which have had no movement of FMD susceptible animals onto it in the previous 6 days for cattle and sheep, 20 days for pigs.
- d. All stock leaving the market to any destination, other than a slaughterhouse, will trigger a 6 day standstill (20 days for pigs) on the premises of destination.
- e. Farm Assurance Declaration: It is the responsibility of the vendor to provide true and complete details regarding Farm Assurance. The residency period for livestock for slaughter is 90 days for cattle and 60 days for sheep. If details provided by the vendor are incomplete or incorrect the purchaser of the lot(s) may at their discretion lodge a claim, in which case the vendor will be liable.
- f. I/We agree to comply with the Animal Gatherings Order Agreed Procedure which has been approved for Newton Abbot Market.
- g. I/We understand that should for any reason stock of mine/ours which cannot be offered for sale by auction and have to be returned to premises of departure, or disposed of, I/We will not hold the Market/Auctioneers responsible and will pay all costs incurred.

### 2.0 TB Declaration (Please delete 2a or 2b as appropriate) As from 1<sup>st</sup> January 2010

- a. All cattle listed were either pre-movement tested within the last 60 days, are under 42 days of age or came onto the holding within the last month and were pre-movement tested if required, the first date of the test being stated on the front page of this entry form. **These Cattle Must Be Unloaded On The Green Unloading Bays, Or For Non-Tested Cattle (On Non Store Days)**
- b. The cattle listed on the front page of this entry form are to be sold in the exempt section in the market for untested cattle. These cattle can only be sold direct to slaughter, an exempt finishing unit or returned to the premises of origin. **These Cattle Must Be Unloaded On The Red Unloading Bays.**
- c. If the cattle are subsequently found to have required a pre-movement test, I/We will indemnify the purchaser and any other subsequent purchaser their reasonable costs arising from any post movement testing required.

### 3.0 Food Chain Information (FCI)

I/We confirm that:-

- a. The holding of departure is not under movement restriction for Bovine tuberculosis (TB). Applies to cattle only.
- b. Cattle/Sheep and Goats on the holding are not under movement restrictions for animal disease or public health reasons (excluding a 6 day standstill).
- c. Withdrawal periods have been observed for all veterinary medicines and other treatments administered to the animals while on this holding and previous holdings.
- d. To the best of my/our knowledge the animals are not showing signs of any disease or condition that may affect the safety of meat derived from them.
- e. No analysis of samples taken from animals on the holding or other samples has shown that the animals in this consignment may have been exposed to any disease or condition that may affect the safety of meat or to substances likely to result in residues in meat.
- f. All stock are fit for human consumption.

#### Livestock Vehicles

All livestock vehicles may be cleansed and disinfected on site or, if a self-cleansing licence is obtained, they must be washed out and disinfected within 24 hours of completing the movement. If the gate is unmanned and you require assistance then please call at the Market Office.
